Subject: - Revision of Mess Fees from Jan 2013

Students are hereby informed that the Mess Committee and University Authority has agreed to revised the mess fee from January 2013 as follows;

- 1) LLM Rs.12000/-
- 2) LLB (1sto 4th Year) Rs.12000/-
- 3) LLB (5th Year) Rs.9500/-

Fees can be remitted by following ways;

- 1. <u>If already deposited Rs. 10,000/- (LLM & LLB 1st to 4thYear)</u>:Remaining Rs. 2000/- should be paid using attached Bank-slip either in cash or DD at Service Counter of the Corporation Bank latest by 31st January 2013.Payment after 31st January 2013 shall entail late fees payment of Rs.10/- per day.
- 2. If DD of Rs. 10,000/- has been prepared but yet to deposit(LLM & LLB 1st to 4th Year): Payment of Rs. 10,000/- can be made to the Accounts Department and it will attract late fee of **Rs. 10 per day** starting from 16.01.2013. Remaining Rs. 2000/- should be paid using attached Bank-slip either in cash or DD at Service Counter of the Corporation Bank latest by 31st January 2013. Payment after 31st January 2013 shall entail late fees payment of Rs.10/- per day.
- 3. If no DD is prepared for mess fee(LLM & LLB):DD of Rs. 12000/-(Rs.9500/-LLB 5thyear)should be remitted by **DD** in favour of "Gujarat National Law University" payable at Ahmedabad in Accounts department with late fees of Rs.10 per day starting from 16th January 2013.

Note: Service Counter of the Corporation Bank is at Ground Floor opposite to <u>Fakkiresh Sir's</u> cabin and it will be operational during 3:00 to 5:00 PM (Monday to Friday) and 11:00 AM to 1:00 PM (Saturday) from <u>21st January 2013.</u>
